ACCIDENT WAIVER AND RELEASE OF LIABILITY

I acknowledge that this athletic event is an extreme test of a person's physical and mental limits and carries with it the potential for death, serious injury and property loss. The risks include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of athletes, equipment, vehicular traffic, actions of other people including, but not limited to, participants, volunteers, spectators, coaches, event officials and event monitors, and/or producers of the event, and lack of hydration. These risks are not only inherent to athletics, but are also present for volunteers. I hereby assume all of the risks of participating and/or volunteering in this event. I realize that liability may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained or controlled by them or because of their possible liability without fault.

I certify that I am physically fit, have sufficiently trained to be a participant in the event and have not been advised otherwise by a qualified medical person. I acknowledge that this Accident Waiver and Release of Liability form will be used by event holders, sponsors and organizers, in respect of events in which I may participate and that it will govern my actions and responsibilities at said events.

In consideration for my application and participation in this event, on behalf of myself and on behalf of my representatives, executors, administrators, heirs, next of kin, successors, and assigns I hereby: (A) Waive, Release and Discharge ALLIANCE PROCURE ("**PROCURE**"), its directors, officers, employees, volunteers, agents, event holders, event promoters, event sponsors, event volunteers, event permit grantors, event property owners, and event participants (the "**Released Parties**"), from any and all claims, actions, demands and damages of any nature whatsoever, including but not limited to liability for my death, disability, personal injury, property damage, property theft, lost income, or any other losses, costs or actions of any kind which hereafter may accrue to me by virtue of my training for this event, my participation in this event or my travel to or from this event; and (B) Agree to indemnify, defend and hold harmless the Released Parties from any and all liabilities or claims made by other individuals or entities resulting from any of my actions during this event.

I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident and or illness during this event.

I understand that at this event or related activities, I may be photographed. I hereby consent to the publication or other use of my photo, video or film likeness by PROCURE, the event holders, producers, sponsors, organizers or assigns for any legitimate purpose, including marketing and promotional material related to PROCURE or its successors or assigns.

PROCURE and the organizers of this race do not provide insurance coverage for injuries that occur at the race. The costs related to those injuries are the responsibility of the individual participant.

I agree that this Accident Waiver and Release of Liability form shall be interpreted in accordance with the laws of the Province of Quebec.

I acknowledge that this document was drafted in the English language at the express request of the parties.
